
Subject: Appeal in respect of Hindi movie 'Sameer'

The matter had been fixed for further consideration. Notice in this appeal had been issued for further hearing today. Affidavit of Shri Dakxinkumar Bajrange had been placed on record. Mr. Harshvardhan Jha, appeared on behalf of the appellant. He made the following statement:

Statement of Shri Harshvardhan without oath

I have been instructed by Shri Dakxinkumar Bajrange, the Managing Director of the appellant to withdraw the affidavit dated 24<sup>th</sup> May, 2017 filed before the Tribunal. I have been instructed to state that the appellant is amenable to deletion of the expletives as required in Cut No. 2 and would further abide by the decision of the Tribunal with regard to deletion and retention of others based on the theme and context of the movie. I further state that the scene mentioned in Cut No. 4 had inadvertently appeared and the appellant has no difficulty in the removal of the same. The appellant would also reduce the scenes as required under Cut No. 6 in particular, those relating to the child and others showing blood flowing. The appellant would also modify the words 'Man ki Baat' further delete the dialogues 'Delhi ka rasta UP se hokar jata hai' and 'Chai se lekar Chutiya banana' The appellant also undertakes to play a prominent disclaimer to be shown at the commencement and as voiceover.

2. In view of the foregoing cuts/deletions and such other cuts as the Tribunal may deem fit, the appellant may be granted 'UA' certification with parental caution.




